**SUBJECT:** The White House Office of American Innovation

To ensure that America remains the global innovation leader, I hereby direct the Senior Advisor to the President to head an office in the White House dedicated to American innovation. This office will bring together the best ideas from Government, the private sector, and other thought leaders to ensure that America is ready to solve today's most intractable problems, and is positioned to meet tomorrow's challenges and opportunities. The office will focus on implementing policies and scaling proven private-sector models to spur job creation and innovation.
