Hi Heath,

I am back on campus at NCSU on Friday and currently open (other than a pile of term papers to grade anyway...). Happy to talk about it.

As an update, we did our 'sidebar discussion' with the DARPA Safe Genes team this afternoon and this subject came up, but not for any sustained discussion really. There was mainly a feeling on the part of the program folks that they wish they had a chance to respond I think. The program officer (Renee Wegrzyn) felt that some of the points had been previously addressed, but that that was not reflected in the piece. Overall, it is fine in the context of the Safe Genes project, but I appreciate the need to talk about communication within the group. This is timely as the formal announcement will be coming in perhaps 4-6 weeks and there will be substantially more media attention than probably (as you have repeatedly noted).
